Section 2:

I declare that all lambs in this consignment:

- a) Comply with all current relevant legislation

- e) The haulier used (if applicable) is a member of the Red Tractor or QMS Farm Assurance Haulier Scheme and the animals were fasted for at least 3 hours prior to loading
- f) To the best of my knowledge the animals have not been treated with quinolones or 3rd and 4th generation cephalosporins.
- g) All animals comply with the 2 Sisters Red Meat 'clean livestock policy'. I understand that any dirty animals may be clipped at my own expense

Section 3:

Compulsory Food Chain Information: Sheep and goats on this holding are NOT under movement restrictions for any animal disease or public health reasons (excluding a 6-day standstill). Withdrawal periods have been observed for all veterinary medicines and other treatments administered to the animals whilst on this holding and previous holdings. To the best of my knowledge none of the lambs in this consignment are suffering from any disease or condition that may affect the safety of the meat derived from them. No analysis of samples taken from these animals or other animals on the holding has shown that the animals in this consignment have been exposed to any disease or condition that may affect the safety of meat or to substances likely to result in residues in meat.
